# THIS IS TO RELEASE YOUR GST/HST ADMINISTRATIVE BURDEN

If you have registered for GST/HST, or if you should have registered for GST/HST, please inform us by submitting GST/HST request form for Enagic commissions issued up to December 31, 2019. This GST/HST must then be reported on a GST/HST return and paid to Canada Revenue Agency ("CRA").

You should have registered for GST/HST if your business revenues (including commissions from Enagic plus all other worldwide [taxable supplies](#) of any other businesses that you run) were more than \$30,000 over four consecutive calendar quarters.

Going forward, there is an election which is available to Enagic and ALL of our distributors if we receive the attached form, completed by every distributor (GI-052, The Network Sellers Method). Since the election is authorized by CRA effective January 1, 2020, we can ignore the GST/HST on commissions issued on or after January 1, 2020. That is, even if you were registered, or should have been registered, you will not be required to account for GST/HST or collect or remit it on commissions from Enagic. However, please note that this does not apply to the GST/HST on any other business that you may have.

The NSM approval may be revoked under several conditions such as by neglecting to maintain an up-to-date list or database containing the names of each distributor with whom we made a joint election.

To negate your administrative burden for GST/HST on Enagic commissions, please read the form carefully, fill out all the information, sign it and email to Enagic.
